
System Requirements

- · Computer with an available USB port
- Compatible with Windows[®], Mac[®] and Linux operating systems
- Compatible with Android[™] devices (tablets/phones) with USB Host Mode (OTG) support and Android OS version 3.2 and above (see the Android compatibility list file at Tripplite.Eaton.com)
- Android-powered devices will require a USB Host Mode (OTG) cable such as the U052-06N to connect to the U209-000-R

Note: The following instructions show how to install the driver on a Windows 7 computer. The installation steps will be similar for other Windows operating systems. For non-Windows operating systems, reference the installation files at Tripplite.Eaton.com. Compatible Android devices do not require a driver for use with the U209-000-R, but do require that a terminal server application be downloaded. The Prolific PL2303GS USB-UART app is recommended and can be found in the Google Play Store.

 Without connecting the U209-000-R, power on your computer. Drivers for the cable can be downloaded from Tripplite.Eaton.com.


2. When the driver installer program launches, click the *Next* button to start installation.



3. The driver installation begins. A progress bar tracks where you are in the installation process.

 Once the installation process is complete, click the *Finish* button to close out of the program.




5. Connect the U209-000-R to an available USB port on your computer. Windows will detect the adapter and assign it a COM port upon completing the installation.

6. To verify that your adapter has been successfully installed, navigate to your computer's Control Panel and open the Device Manager screen. The adapter will appear in the Ports section, with its assigned COM port next to it.
