1. Plug the USB connector on the adapter into an available USB port on your computer. Upon connecting the adapter to your computer, the device will begin installing.
2. Wait for the installation process to reach completion. You may need to restart your computer.
3. Connect the Ethernet port on the adapter to your LAN port using a Cat5e/6 cable.
