Installation

Notes:

- Hard drives are sensitive to static electricity and must be handled properly to prevent data loss. Always handle
 your hard drive with caution: wear an anti-static strap (Tripp Lite model: P999-000) when transporting it, or
 touch a grounded metal surface to discharge yourself of static electricity prior to handling the drive.
- If your drive has not been formatted, it will need to be formatted using your computer's Disk Management utility in order to copy and access files.
- Before unplugging the adapter, make sure you properly eject the drive from your computer to avoid any
 potential data loss.
- 1. Connect the external power supply to the U439-001 and plug it into an appropriate power source. Turn on the power to the U439-001.
- 2. Connect the U439-001 to your computer using the included USB-C cable. The blue LED on the unit will illuminate to indicate a link with the USB port on the computer.
- Connect your 2.5- or 3.5-inch SATA drive to the port on the unit. Upon connection, the SATA drive will be recognized by your computer.
